# New Kent County Getting Registered

### New Kent County Business License

New Kent County Code states it is mandatorythatanypersonengaging in business, trade or profession in New Kent County shall apply for a business license prior to conducting business. Each person subject to a license tax under this article, Code of Ordinances, shall apply for a license to the Commissioner of the Revenue prior to beginning business if he/ she was not subject to licensure in the county on or before January 1st of the license year, or no later than May 1st of the license year of he/ she had been issued a license for the preceding year. Once you have submitted your business license application you will receive your certificate through the mail, usually within a week.

**Do I need a business License?** New Kent County requires all businesses (include home occupations) to file for a license, with the exclusion of outof-county contractors doing less than \$25,000 and manufacturers.

#### File for a Business Name

In order to receive a New Kent County business license, your business name must be filed with the State Corporation Commission. The local Commissioner of the Revenue will not issue a business license or accept registrations for other local taxes without this registration. Businesses physically located in New Kent County (store front, home office, etc.) are required to file a Certification of Zoning application with the New Kent County Planning Department before receiving a New Kent County business license. A copy of the approved certification must be submitted with your business license application.

#### Virginia Department of Health (VDH)

Multiple businesses, including businesses engaging in food handling, are required to obtain approval from the local office of the VDH and to periodically have inspections of their facilities in order to assure safety/ sanitary organizations within New Kent County. Permits are issued for restaurants, mobile food units, temporary food service events, school/daycare kitchens, and almost every time food is prepared for or served, to the public. These operations are permitted annually, and there is a permit application fee.

#### **Building Development**

The New Kent County Building Development enforces the Virginia Uniform Statewide Building Code. This code includes plan review, permit issuance, and inspection of buildings and structures during the construction phase of your business. All structures are required to have a permit, except non-residential farm buildings as stated in the Virginia Uniform Statewide Building Code.

#### How long is a permit good for?

All permits are valid for six months from the time that the permit is issued. A permit extends for another six months every time that there is an inspection on the project.

#### How do I schedule an inspection?

Please call the inspection line at (804)966-8572 and follow the prompt to leave your permit number and type of inspection requested.

State Contractor Licenses, Tradesman Licenses, Certified Water Well System Providers, Certified Elevator Mechanics and Certified Backflow Prevention Device Workers

> People, firms, or corporations engaging in additions to existing structures or the construction of new structures, or those a part of some form of remodeling, repair or demolition of existing structures are required to be licensed in the Commonwealth of Virginia, in addition to being registered in New Kent County. An individual certification/license issued by the Board for Contractors may be required if an individual is performing work on elevators, water well systems, escalators, plumbing, electrical, HVAC, or gas. This requirement is relevant but not limited to: building contractors, commercial contractors, residential and subcontractors (plumbing, electrical, etc.).


All of New Kent County taxes are assessed by the Commissioner of the Revenue and payable to and collected by the Treasurer's Office.

### Commissioner of the Revenue Tax Rates

All tax rates are set annually by the Board of Supervisors.

- Mobile Home: \$0.67
- Bottoms Bridge Service District: \$0.05
- Tangible Personal Property: \$3.75
- Handicap Equipped Vehicles: EXEMPT
- Aircraft: \$0.75
- Machinery Tools: \$0.75

#### 2022 Consumer Tax Rates

Tax Category- Tax Levied

- Meals: 6%
- Transient Occupancy/Lodging: 2%

#### 2021 Business License Tax Rates

License Category- Rate per \$100

- Contractor: \$0.12
- Retail Sales: \$0.15
- Wholesale: \$0.04
- Repairs, Personal, Business & Other Services: \$0.27
- Financial, Real Estate & Professional Services: \$0.44
- Utility License Tax: \$0.42
- Miscellaneous License: \$0.27

I work out of my home; do I still have to file? Yes. The business personal property tax must be paid on all business equipment.

**Do I have to file if I have no equipment to report?** If your business is located in New Kent County, you must report each year even if you do not have any equipment.

#### **New Kent Fire Code**

The County of New Kent adopted the Statewide Fire Prevention Code. A person in the county shall request and receive permits from the fire marshal before starting that activity. The fire marshal shall establish procedures for inspections, issuance of permits and other functions necessary for administration of this requirement.
